Turned said highway through y^e field for there accomodation. Beginning at
y^e hill or Drying Ground Northerly of y^e Goodenows house at a stake and
stone In to Joseph Goodenows field y^e highway is Laid out on y^e north
Side of y^e Stake & stone & so on In to y^e field to a stake and stone at y^e turn
and so on In to y^e field Northerly to a wild Cherry tree marked Near to a tall
pine tree. Said Cherry tree stands In or by to Goodenows field fence
on y^e Southerly Side of y^e highway Loading from Wales Bridge to Zebediah
Allens and is Laid out on y^e westerly Side of y^e Cherry tree and is Laid all
y^e way through y^e field two Rods wide Excepting at y^e Stake and stone In
y^e middle of y^e field y^e highway is Laid out two Rods and a half wide
