To y^e Constable of Sudbury We order you to warn y^e Inhabitants of and belonging to this Town to meet at y^e Meeting house on Thirs^{day} y^e 13th of this instant Decr at 12 of y^e Clock of sd Day then and then to transact sum^{ing} further as to y^e weighty matters now depending betwixt y^e Town of Sudbury and Mr James Sharmen: also to transact sumthing further as to y^e support of y^e ministry also to act sumthing as to Deacon Noyses his Request for Enter^{tain}ing y^e ministers and make Return of s^{aid} y^e select men at y^e time and place appoynted by order of y^e select men of Sudbury Richard moore Town Cl^{erk}.

Constables Inobedience to y^e above written order I have warned y^e Return Inhabitants of and belonging to this town to meet at time and place to do y^e work set forth in y^e above written order Joshua Haynes Const^{able}.

Sudbury Decemr 15: 1705 } at a Town meeting:
Legally warned y^e Town being met and assembled y^e 15th of Decr 1705 } to y^e work of y^e day: first Chose Mr John Brigham Moderator: 2^{ly}: agreed and Voted y^e shew a Rate made of hoonly time p^{er} ann^{um} for y^e support of y^e ministry and also to answer Deacon Noyses Charges for enter^{tain}ing y^e ministers:

To y^e Constable of Sudbury we order you to warn y^e Inhabitants of and belonging to this town to meet at y^e meeting house on y^e 26th of this instant at 12 of y^e Clock of sd Day to sd y^e Town will concur to y^e Churchs Choyce as to y^e settlement of a minister y^e Church having had a meeting on y^e 30th of this instant and s^{aid} made Choyce of Mr Loring to be their pastor: and also give an answer to a letter of y^e select men have Rec^d from Mr James Sharmens attornies where in y^e Desir a p^{ro}posall answer to y^e Request as if they left to y^e Town of Sudbury hereof fail not and make Return to y^e select men at y^e time and place appoynted: This by order of y^e select men of Sudbury Richard moore Town Clark:
