

- 12th To See if the Town will choose a Comm^{tee} of Two Men to Apprize and Sell unto Maj^r Josiah Richardson James Craig and Hopestill Brown (at their Cost) a Certain piece of Land in the thirty Rod High Way - Agreeable to their Petition.
- 13th To see if the Town will choose a Comm^{tee} to Build a Work House in S^d Town - And Grant a Sum of Money for the Same
- 14th To See if the Town will Grant the Rev. Mr Israel Loring an Honourable Gratuity the present Year, including his Salary & Firewood
- 15th To See if the Town will Grant to Mr Josiah Bridge his Settlement and Salary, As he has Contracted with the East Society for in^d
- 16th To See if the Town, by their Vote, will Order the Town Treasurer to Call in the money, due on the Bonds taken for the Lands sold in the New Grant High Ways (so called) in S^d Town - so that it may be Appropriated to defrey some of the Publi^k charges in S^d Town

And make due Return of this Order with your doings thereon to the Select Men at time and place within mentioned

In Observance of this within Order I have warned the freeholders ~~the~~ and other Inhabitants in my Ward, Qualified to Vote in Town Affairs, As the Law Directs to meet at Time and Place

The Return of the other three Constables Orders were as the Law Directs and Accepted by the Town

At a Meeting of the Town of Sudbury Legally Warned Octob^r 28th 1761 the Town being met at time and place proceeded and chose Col Hayes Mod^r then the Town proceeded as follows - And Allowed the following Debts viz^t
