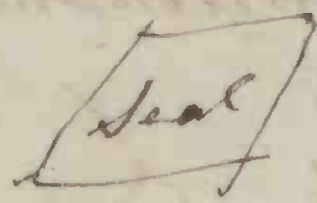

Meddlesett ss. To Christopher G. Cutler Constable of the
Town of Sudbury in said County Greeting.



You are hereby required in the Name of the Commonwealth
of Massachusetts to notify and warn all the male Inhabitants
of said town of Sudbury qualified as the Law directs to Vote in the
choir of town officers and town affairs to meet at Meetinghouse in said
town on Monday the 1st day of March next at ~~twelve~~ 11 o'clock at
noon on said day thin and there to act on the following Articles (Viz)

- 1st To chuse a Moderator, Town clerk, Selectmen, Town Treasurer,
Assessors, Constable, School Committee, and all other Town officers
that the Law requires to be chosen in the month of March or April
- 2^d To see if the town will repair their Highway by a rate the present year
And grant a suitable sum of money to repair the same
- 3^d To see if the town will grant a suitable sum of Money for the support
of the Winter School and order how the same shall be distributed.
- 4th To see if the town will grant ~~a suitable~~ money for the support of the
summer schools and order how the same shall be distributed.
- 5th To see if the town will give liberty for swine, Horses, Mules, neat cattle,
and sheep to graze at large the present year without a keeper.
- 6th To see if the town will what measures the town will take in letting out
the Poor of said town the present year for one or more years to one
or more contractors, to do or act, any way as it respects the disposal of the
poor as the town shall think best when meet
- 7th To see if the town will take the same measures in letting out the collecting
the taxes that may be assessed upon the Inhabitants of said town the present year
as was adopted the last year. And agree with some suitable person, or persons,
to collect the same.
- 8th To see if the town ^{will chuse} a committee to examine all accounts and allow the
same that may be brot in against said town the present year.
- 9th To attend to the report of the trustees of the Ministerial fund Corporation
and order the same to be recorded.
- 10th To see if the town will take any measures to new district the town and build
two or more School Houses to do, or act, as the town shall think best when meet
- 11th To see if the town will appoint a committee to purchase a piece of land at
the west end of the burying yard off of the estate of Walter Mayors deceased to enlarge
the same to do, or act, ~~the~~ town shall think best when meet
- 12th To see if will take any measures to purchase a stove to be placed in the meeting
house to do or act as the town shall think best when meet
- 13 To see if the town will appropriate any unappropriated money now in
the Treasurer for the purpose of defending suits now pending against
the town to do or act as the town shall think proper

And you are hereby directed to serve this warrant by posting up
~~this warrant~~ an attested copy thereof at the public meeting house
in said town two sabbaths at least before the time set for holding
said meeting - Hereof fail not and make due return of this Warrant
with your doing thereon to our selves at the time and place
of holding said meeting -
